## Colorado Privacy Notice Supplement Effective 07/01/2023

### PERSONAL DATA PROCESSING PRACTICES

This Privacy Notice applies only to Colorado consumers (“you” or collectively as “consumers”) and supplements the Privacy Policy of Leisure Care LLC & OneEighty Twist and any of its subsidiaries (collectively, “we,” “us,” or “our”) accessible on our website, [www.leisurecare.com](http://www.leisurecare.com). The Colorado Privacy Act (“CPA”) provides Colorado consumers with specific rights regarding their personal information.

In addition to the online Services in the Privacy Policy, we maintain a mobile application, MyLeisureCare, that may ask you to provide us with the same personally identifiable information for the same purposes. A link to our Privacy Policy notice can be viewed prior to downloading the application and the link is included on the application’s landing page.

Offline, we may ask you to provide us with the same personally identifiable information for the same purposes. While we do not process the personal data of children, we may request sensitive data of prospective and existing residents specific to their occupancy at a residence, which is managed in accordance with applicable privacy and consent policies. Offline versions of our Privacy Policy notices are available to consumers upon request.

### COLORADO DATA RIGHTS

Under the CPA, consumers are defined as Colorado residents who are acting only in an individual or household context, or a person/entity authorized to act on a consumer’s behalf. It does not apply to consumers acting in a commercial or employment context, including job applicants or beneficiaries of someone acting in an employment context. Colorado consumers have the following rights:

Right	You have the right to:
Right to Opt Out	Opt out of the processing of your personal data concerning for the purposes of a) targeted advertising, b) the sale of personal data, or c) profiling in furtherance of decisions that produce legal or similar effects to you.
Right of Access	Confirm whether we are processing your personal data and that we provide access to your data.
Right to Correction	Correct inaccuracies in your personal data.
Right to Deletion	Delete your personal data.
Right to Portability	Obtain your data in a format that allows you to transmit the data to another entity.
Right to Appeal	Appeal our actions regarding your requests and contact the attorney general if you have concerns about the results of an appeal.

### RIGHTS REQUEST

You may contact us via the means identified in our online Privacy Policy or by completing and submitting the attached Colorado Privacy Rights Request. If we decide not to act on a request, you may appeal our decision using the Colorado Privacy Rights Request form and indicating “Right to Appeal”.

### AUTHENTICATION

To protect your privacy, we will ask you or your authorized agent to verify your identity. We will ask you to confirm your name, email address, phone number and other information so that we can reasonably confirm your identity. We will not share any information until we can reasonably confirm your identity. If we deny your data right request based on inability to authenticate, we will describe the efforts we took and why we were unable to authenticate the request.

### UNIVERSAL OPT OUT MECHANISM (UOOM)

The State of Colorado has identified a UOOM, Global Privacy Control. Effective July 1, 2024, if your browser supports it, you can turn on the Global Privacy Control to exercise any and all opt-out rights available to you under state laws.
